Registration process

Registrations will be accepted beginning on September 24, 2007 until the time that camp is filled. Applications are processed in the exact order that we receive them. All pages of the registration form must be submitted and initialed at the bottom. Page 3 must be signed and dated. We are accepting 88 participants, 16 QUALIFIED workers, and an unlimited number of auditors. A deposit is required to secure a spot. You must provide a \$250 non-refundable deposit with your registration as a working team, \$125 for auditors, \$25 per day for daily auditors and \$100 for workers. Applicants for worker spots will be notified as to whether or not their application has been accepted by December 31, 2007. When all spots have been filled, we will begin a waiting list.

I am aware that there are inherent risks and hazards involved with and around dogs, and I am voluntarily participating in the activities with the knowledge of these potential dangers. I am not relying on CSPOTWIN AGILITY OR STACY PEARDOT-GOUDY to prevent such occurrences. In order to participate in CSPOTWIN AGILITY training classes, demonstrations, or other activities, I, being fully informed of such risks and hazards, agree to assume ALL RISK OF SUCH OCCURRENCE. I hereby waive any and all claims or actions I or my guardians, representative or assigns may have against CSPOTWIN AGILITY OR STACY PEARDOT-GOUDY and agree to release CSPOTWIN AGILITY OR STACY PEARDOT-GOUDY from liability in any and all personal injuries to myself, my dog, children in my charge, or harm to property causes directly or indirectly by any acts that might occur in conjunction with dog training classes, or other activities. I also agree to assume sole responsibility for injury or damage caused by myself, children in my charge, or by the dog I own or handle during participation in CSPOTWIN AGILITY classes, events and activities and further indemnify, defend, and hold CSPOTWIN AGILITY OR STACY PEARDOT-GOUDY harmless from any damage, loss, liability, or expense, including legal costs and attorney fees, which result from damage caused by myself, children in my charge, or the dog I own or handle.

RELEASE OF LIABILITY -- I have carefully read this release of liability and fully understand the contents thereof. I am aware that this is a release of liability and a contract between CSPOTWIN AGILITY, and me and I agree to it of my own free will.

Cancellation Policy

As much as we care about all of our customers and their dogs, and we are extremely pained when we hear of either personal or canine tragedies, camp is a business. We cannot keep running camp if costs are greater than income and labor expended. We budget and hire instructors for camp based on being able to fill an exact number of spots. The instructors and the facility don't care how many people ultimately attend camp - they charge us the same amount of money no matter what. We had to develop a cancellation policy that takes this into consideration and that treats everyone equally. We do not

make exceptions to this policy as it is impossible to judge whether one person's emergency is more important and more deserving of a refund or credit than the next person's. We do the best we can to maintain an active waiting list, but we cannot guarantee that there will be a waiting list if you have to cancel.

It is critical that you read the following information carefully as there are NO exceptions to our cancellation policy other than being called to active military duty.

- Your initial deposit -- \$250 for participants, \$125 for auditors, and \$25/day deposit for day auditors -- is NON-REFUNDABLE. Any camp cancellation, regardless of reason, forfeits that deposit. Workers will be refunded \$100 upon the completion of day 4 of camp.
- If you cancel your camp reservation after April 1, 2008, you will forfeit 50% of the total camp fees paid; the balance of fees will be refunded ONLY IF your spot can be filled with an eligible participant. It is highly unlikely that we will be able to fill cancellations during the month prior to camp as it's too late for people to make plans. If we cannot fill your spot, you will forfeit 100% of the total camp fees paid.
- All participant and worker fees are non-transferable.
- Auditors who are unable to attend camp may transfer their auditing spot to another person as long as an application is filled out with Cspotwin Agility prior to June 15, 2008.

CANCELLATION POLICY -- I have read the above cancellation policy and I agree to all terms. I understand that there are NO EXCEPTIONS to the policy regardless of the reason that I cancel my Camp reservation. I understand that cancellation after April 1st may result in my receiving NO REFUND if my spot in Camp cannot be filled from the waiting list. I also understand that I may not give nor sell my spot in camp to another person unless I am an auditor.
